## Communicable Disease Conference Speaker Bios

Shannon Calus received her Bachelor's Degree in Chemistry from the University of Illinois at Urbana Champaign in 2013. She then went on to receive her Master's Degree in Public Health from Loyola University in 2019. She is currently working at the Hektoen Institute of Medicine as a project specialist and organizes antimicrobial stewardship activities for the State of Illinois through a grant agreement with the Illinois Department of Public Health. She is also the lead organizer for the annual Illinois Summit on Antimicrobial Stewardship, a yearly event that brings together providers from various healthcare settings to discuss current best practices and lessons learned around the appropriate use of antibiotics.

Michelle Ealy MSN-PH, BSN, RN has 32 years of experience as a registered nurse. Michelle previously worked with the Illinois Department of Family Services for 25 years as a Child Welfare Nurse Consultant/Specialist and Chief of Nursing Services. Michelle joined the IDPH Divisions of Communicable Disease and Patient Safety and Quality in 2017 as a Statewide Infection Control Coordinator in a unique nursing role of outbreak response and prevention...bridging gap between infectious disease identification and public health response/prevention.
